

Uniform Safety Release Agreement

Release of Liability and Covenant Not to Sue

PLEASE BE ABSOLUTELY SURE TO READ THIS AGREEMENT IN ITS ENTIRETY AND UNDERSTAND ITS CONTENTS THOROUGHLY BEFORE YOU CONSENT TO IT BY SIGNING IT BELOW. THIS WAIVER AFFECTS YOUR LEGAL RIGHTS WITH RESPECT TO YOUR PARTICIPATION IN RED BUTTON PRODUCTIONS SPONSORED EVENTS SO, BY YOUR CONSENT, YOU WILL BE LEGALLY BOUND TO THESE RESTRICTIONS ON YOUR RIGHTS.

I, the undersigned, understand that Red Button Productions has taken all reasonable precautions and measures to minimize risks to participants, but are unable to completely guarantee that no injury will come to me. Since the events are mainly conducted outdoors in wilderness areas, there is always the possibility of a slip on rough ground, a fall over obstacles in darkness, or the occurrence of some other unforeseeable accident. Further, since I may also be participating in mock battles using padded weapons, there is the risk of injury from other participants. At all times, I will consider the game a "Full Contact Sport," even though safety rules and regulations exist which prohibit bodily contact during these mock combats, except by recently inspected and approved simulated weapons.

I understand the risks involved in participating in events sponsored by Red Button Productions. I do hereby release, acquit, exonerate and discharge this organization, its members, officers, employees, agents, designated representatives or any company doing business with them from any and all claims, demands, actions, or causes of actions which might arise from my participation in this organization's sponsored events, including damage to any property or injury or death of any person(s), including myself.

I confirm that I am in good physical health and do not suffer from any physical disabilities unknown to the organization. I agree also to the following restrictions placed upon me by Red Button Productions:

I will not use the padded weapons approved by the organization unless I have first completed the safety training course; I will not bring or consume alcoholic beverages or any other drug during the event; I will not use any skills taught by the organization for illegal purposes; I will, at all times, abide by all rules and regulations of the organization.

I understand that failure to abide by these restrictions could result in expulsion from the organization.

By my signature, I confirm that I have read this release, understand its terms, and agree to its provisions in their entirety. I also understand that this form affects my legal rights.
